A RESOLUTION APPROVING A PERFORMANCE CONTRACT
WITH SALAMANDER MUSIC FOR 2014 BUTLERVILLE DAYS

WHEREAS, the city council (the "*Council*") of the city of Cottonwood Heights (the "*City*") met on 17 June 2014 to consider, among other things, approving a "Performance Contract" (the "*Agreement*") with Salamander Music ("*Contractor*") whereunder the City would engage Contractor to provide a musical performance at the City's 2014 "Butlerville Days" community celebration on the terms and conditions specified in the Agreement; and

WHEREAS, the Council has reviewed the form of the Agreement, a photocopy of which is annexed hereto as an exhibit; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to approve the City's entry into the Agreement as proposed;

NOW, THEREFORE, BE IT RESOLVED by the city council of Cottonwood Heights that the attached Agreement with Contractor is hereby approved, and that the City's mayor and recorder are authorized and directed to execute and deliver the Agreement on behalf of the City.

This Resolution, assigned no. 2014-33, shall take effect immediately upon passage.


