A RESOLUTION APPROVING AND RATIFYING A BID AND AWARDING A CONSTRUCTION CONTRACT TO CSM CONSTRUCTION, INC. (PUBLIC WORKS YARD-SALT STORAGE SHED)


WHEREAS, the city council (the "Council") of the city of Cottonwood Heights (the "City") met on 9 February 2016 to consider, among other things, (a) approving and ratifying the City's acceptance of a \$489,733.90 bid from CSM Construction, Inc. ("Contractor") for construction of a public works yard salt storage shed under the City's project no. CHC287SS (the "Project"); and (b) authorizing the City's entry into an agreement for such construction services (the "Agreement") with Contractor on such terms and conditions as may be approved by the City's mayor and manager in consultation with the City's director of public works, the City engineer and the City attorney, a draft copy of which is annexed as an exhibit hereto; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to approve and ratify the City's acceptance of Contractor's bid for the Project and to authorize the City's entry into the Agreement with Contractor as proposed;

NOW, THEREFORE, BE IT RESOLVED by the city council of Cottonwood Heights that the Council hereby (a) approves and ratifies the City's acceptance of Contractor's bid for the Project, and (b) authorizes the City's entry into the Agreement with Contractor on such terms and conditions, and with such modifications, as may be approved by the City's mayor and manager in consultation with the City's director of public works, the City engineer and the City attorney.

This Resolution, assigned no. 2016-11, shall take effect immediately upon passage.

AGREEMENT

THIS AGREEMENT, made this 13th day of January, 2016, by and between the CITY OF COTTONWOOD HEIGHTS, UTAH, hereinafter called "OWNER" and CSM Construction, Inc. doing business as A Corporation, hereafter called "CONTRACTOR".

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

1. The CONTRACTOR will commence and complete construction of the "SITE IMPROVEMENT PROJECTS FOR NEW PUBLIC WORKS YARD, LOCATED AT COTTONWOOD PARKWAY (6515 SOUTH) ON 3000 EAST STREET; INCLUDING SITE GRADING FOR YARD AND CONSTRUCTING SALT STORAGE BUILDING --- PROJECT # CHC.287, PHASE 1".

2. The CONTRACTOR will furnish all of materials, supplies, tools, equipment, labor and other services necessary for the completion of the PROJECTS described herein.

3. The CONTRACTOR will commence the work required by CONTRACT DOCUMENTS within Five (5) calendar days after the date of the NOTICE TO PROCEED; and will complete the same within SIXTY (60) calendar days after the date of the NOTICE TO PROCEED; unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.

4. The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum as shown in the BID schedule.

6. The OWNER will pay to the CONTRACTOR, in the manner and at such times as set forth in the General Conditions, such amounts as required by the CONTRACT DOCUMENTS.

7. This Agreement shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
