## RESOLUTION No. 2017-04

### A RESOLUTION RE-APPOINTING J. SCOTT BRACKEN AS THE REPRESENTATIVE OF THE CITY OF COTTONWOOD HEIGHTS TO THE ADMINISTRATIVE CONTROL BOARD OF THE WASATCH FRONT WASTE AND RECYCLING DISTRICT

**WHEREAS**, the Wasatch Front Waste and Recycling District (the "*District*") is the successor to Salt Lake County Special Service District No. 1, which was created in 1979 to provide sanitation services in the then-unincorporated area of Salt Lake County (the "*County*"), including the geographical area that now is the city of Cottonwood Heights (the "*City*"); and

**WHEREAS**, by statute, governance of the District is vested in a nine-member administrative control board (the "*Board*"); and

**WHEREAS**, J. Scott Bracken, a member of the City's city council, has represented the City as a member of the Board since January 2012; and

**WHEREAS**, the City has been asked to either re-appoint Mr. Bracken, or to appoint another of the City's elected officers, to serve as a member of the Board; and

**WHEREAS**, the City's city council (the "*Council*") met in regular session on 10 January 2017 to consider, among other things, re-appointing Mr. Bracken as the City's representative on the Board, to serve in such capacity until such time as the Council designates a replacement; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the City's residents to re-appoint Mr. Bracken as the City's representative on the Board as proposed;


**NOW, THEREFORE, BE IT RESOLVED** by the Cottonwood Heights city council that J. Scott Bracken be, and hereby is, re-appointed as the City's representative on the Board until such time as the Council designates a replacement.

This Resolution, assigned no. 2017-04, shall take effect immediately upon passage.
