RESOLUTION No. 2018-18

A RESOLUTION APPROVING ENTRY INTO AN INTERLOCAL AGREEMENT WITH CITY OF HOLLADAY FOR JUSTICE COURT SERVICES

WHEREAS, the Interlocal Cooperation Act, UTAH CODE ANN. §11-13-101 *et. seq.* (the “*Interlocal Cooperation Act*”), provides that any two or more public agencies may enter into agreements with one another for joint or cooperative action following the adoption of an appropriate resolution by the governing body of each participating public agency; and

WHEREAS, City of Holladay (“*Holladay*”) and the city of Cottonwood Heights (the “*City*”) are public agencies for purposes of the Interlocal Cooperation Act; and

WHEREAS, Holladay operates a “justice court” (the “*Court*”) pursuant to UTAH CODE ANN. §78A-7-101, *et seq.*; and

WHEREAS, the City is in need of justice court services, and Holladay is willing to provide such services to the City; and

WHEREAS, the City and Holladay jointly desire to enter into an interlocal agreement (the “*Agreement*”) whereunder Holladay will provide justice court services to the City as provided in the Agreement; and

WHEREAS, the City’s municipal council (the “*Council*”) met in regular session on 27 March 2018 to consider, among other things, approving the City’s entry into the Agreement concerning Holladay’s provision of justice court services to the City under the Agreement; and

WHEREAS, the Council has reviewed the form of the Agreement, a photocopy of which is annexed hereto, and after careful consideration the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to approve the City’s entry into the Agreement as proposed;


