

# COTTONWOOD HEIGHTS

## RESOLUTION No. 2018-66

### A RESOLUTION APPROVING THE APPOINTMENT OF A FINANCE AND ADMINISTRATIVE SERVICES DIRECTOR

**WHEREAS**, UTAH CODE ANN. §10-6-157 provides that the legislative body of a city of the third, fourth or fifth class, or of a town, may create a director of finance position to perform the financial duties and responsibilities of the city recorder or town clerk, as applicable, under Chapter 6 of Title 10, UTAH CODE ANN.; and

**WHEREAS**, the city of Cottonwood Heights (the “*City*”) is a city of the third class and has created the director of finance position in the City’s administration as provided in §2.80.010 - 020, COTTONWOOD HEIGHTS CODE OF ORDINANCES (the “*Code*”); and

**WHEREAS**, Code §2.40.030(D) requires and/or empowers the manager (the “*Manager*”) of the City to appoint, with the advice and consent of the Council, a qualified person to the office of director of finance and a qualified person to the office of budget officer for the City; and

**WHEREAS**, pursuant to Code §2.100.010, the City’s administration includes an administrative services department headed by a director which, pursuant to Code §2.40.030(H), also is appointed by the Manager with advice and consent of the Council; and

**WHEREAS**, the Manager has informed the Council that he desires to appoint **S. Scott Jurges** as the director of finance, the budget officer and the director of administrative services for the City, to serve under the title of “Finance and Administrative Services Director”; and

**WHEREAS**, the Council met in regular session on 23 October 2018 to consider, among other things, giving advice and consenting to such appointment of Mr. Jurges; and

**WHEREAS**, the Council has examined the qualifications of Mr. Jurges and is otherwise familiar with him; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the residents of the City to give advice and to consent to the appointment of Mr. Jurges as the director of finance, the budget officer and the director of administrative services for the City as proposed by the Manager;

**NOW, THEREFORE, BE IT RESOLVED** by the city council of the city of Cottonwood Heights that the Council hereby gives advice and consents to the appointment of **S. Scott Jurges** as the director of finance, the budget officer and the director of administrative services for the City, to serve under the title of “Finance and Administrative Services Director” or such other title hereafter designated by the Manager, as proposed by the Manager.

This Resolution, assigned no. 2018-66, shall take effect immediately upon passage as provided herein.
