

# COTTONWOOD HEIGHTS

## RESOLUTION No. 2022-37

### A RESOLUTION INITIATING REVIEW OF COMPENSATION FOR ELECTIVE AND STATUTORY OFFICERS; ESTABLISHING THE TIME AND PLACE OF A PUBLIC HEARING TO CONSIDER MODIFICATION OF SUCH COMPENSATION; AND PROVIDING FOR PUBLICATION OF NOTICE OF SUCH PUBLIC HEARING

**WHEREAS**, UTAH CODE ANN. §10-3-818 allows a city's governing body to review or consider the compensation of the city's officers for the purpose of determining, following a public hearing, whether or not it should be adopted, changed or amended; and

**WHEREAS**, at a regular session of the city council (the "*Council*") of the city of Cottonwood Heights (the "*City*") on 5 July 2022, the Council initiated its consideration of amending the compensation for the City's elective and statutory officers; and

**WHEREAS**, the Council desires to fully comply with the applicable statutory requirements regarding such matters; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the City's residents to proceed with such consideration and to order a public hearing concerning any resulting proposed amendments to the compensation of its elective and statutory officers;

**NOW, THEREFORE, BE IT RESOLVED** by the city council of the city of Cottonwood Heights that the Council hereby (a) expresses its intent to consider amending the compensation for the City's elective and statutory officers; (b) orders that a public hearing (the "*Hearing*") concerning any resulting proposed amendments to such compensation be held on Tuesday, 19 July 2022, beginning at 6:30 p.m., or as soon thereafter as practical, at 2277 East Bengal Blvd., Cottonwood Heights, Utah, at which time all interested persons in attendance shall be given the opportunity to be heard, for or against, any such amendments; and (c) orders the City Recorder to assure that notice of the Hearing be published at least seven days prior to the Hearing (i) in at least one issue of a newspaper of general circulation published in Salt Lake County, Utah; and (ii) on the Utah Public Notice Website created in UTAH CODE ANN. §63A-16-601.

This Resolution, assigned no. 2022-37, shall take effect immediately upon passage as provided herein.


