## RESOLUTION No. 2022-56

## A RESOLUTION APPROVING THE MID-VALLEY ACTIVE TRANSPORTATION PLAN

**WHEREAS**, in 2019 the city of Cottonwood Heights (the "City") began collaboratively working with the cities of Holladay, Midvale, Millcreek, Murray and Taylorsville to create a regional transportation plan for active transportation not involving motorized vehicles, including walking, biking and other forms of non-motorized transportation; and

**WHEREAS**, as part of this collaboration, an active transportation plan was prepared by Avenue Consultants under sponsorship of Wasatch Front Regional Council ("WFRC"), with support and active participation by the six collaborating cities specified above; and

WHEREAS, the resulting plan is available at www.midvalleyatp.com (the "Plan"); and

**WHEREAS**, the result of that collaborative process is a cohesive Plan that connects and develops an active transportation backbone network across all six of the participating cities in a manner that also coordinates with major stakeholders such as WFRC, Utah Department of Transportation, Salt Lake County, and Utah Transit Authority; and

WHEREAS, the Plan examines regional connections and opportunities for collaboration on implementation while also providing the framework for the six municipalities to identify priorities, policies and routes specific to their respective jurisdictions, thereby serving as a foundation for future budget allocations, multi-jurisdictional grant opportunities, and policy implementation by city staff, elected officials and commissions to ensure the proper construction and modification of roadways to allow for and enhance multimodal transportation; and

**WHEREAS**, on 1 November 2022 the City's city council (the "Council") met in regular session to consider, among other things, approving and adopting the Plan; and

**WHEREAS**, the Council has reviewed the Plan and, after careful consideration, has determined that it is in the best interests of the health, safety and welfare of the City's residents to approve and adopt the Plan as proposed;

**NOW, THEREFORE**, be it resolved by the city council of the city of Cottonwood Heights that the Plan is hereby approved and adopted by the City.

This Resolution, assigned no. 2022-56, shall take effect immediately upon passage.
