## RESOLUTION No. 2024-04

### A RESOLUTION APPROVING AN INTERLOCAL AGREEMENT WITH UTAH DEPARTMENT OF TRANSPORTATION FOR ROADWAY IMPROVEMENTS (WASATCH BLVD. AND BIG COTTONWOOD CANYON ROAD)

**WHEREAS**, the Utah Department of Public Transportation (“UDOT”) is responsible for providing for the safe and efficient movement of all modes of traffic on state highways within the state of Utah, including those within local jurisdictions such as the city of Cottonwood Heights (“City”); and

**WHEREAS**, SR-210 (“Wasatch Blvd.”) and SR-190 (“Big Cottonwood Canyon Road”) (collectively, the “State Roads”) are state highways located, in part, within City’s boundaries that are under UDOT’s jurisdiction; and

**WHEREAS**, City has requested UDOT to install median curb and adjust striping at the intersection of the State Roads as described in a proposed agreement (the “Agreement”) between the parties, a photocopy of which is annexed hereto; and

**WHEREAS**, under the Interlocal Cooperation Act, UTAH CODE ANN. 11-13-101 et seq. (the “Interlocal Act”), any two or more public agencies may enter into agreements with one another for joint or cooperative action; and

**WHEREAS**, City and UDOT are public agencies for purposes of the Interlocal Act and are empowered to enter into the Agreement; and

**WHEREAS**, City’s city council (the “Council”) met in regular session on 2 January 2024 to consider, among other things, approving City’s entry into the Agreement; and

**WHEREAS**, the Council has reviewed the form of the Agreement and has determined that it is in the best interests of the health, safety and welfare of City’s residents to approve City’s entry into the Agreement as proposed;

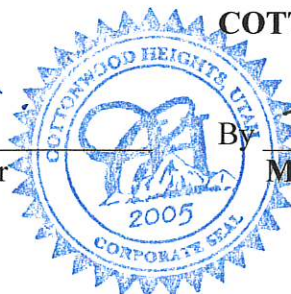
**NOW, THEREFORE, BE IT RESOLVED** by the city council of Cottonwood Heights that the attached Agreement with UDOT is hereby approved, and that City’s mayor and recorder are authorized and directed to execute and deliver the Agreement on behalf of City.


This Resolution, assigned no. 2024-04, shall take effect immediately upon passage.
