## RESOLUTION No. 2024-06

### A RESOLUTION AWARDING A RETIRING POLICE OFFICER HER BADGE AND APPROVING HER PURCHASE OF A POLICE FIREARM

**WHEREAS**, §2.150.060 of the COTTONWOOD HEIGHTS CODE (the “Code”) establishes the procedures for disposal by the city of Cottonwood Heights (the “City”) of its surplus property; and

**WHEREAS**, under Code §2.150.060(H)(2)(a)-(b), the City’s city council (the “Council”) may, by resolution following recommendation by the City’s chief of police (the “Chief”), award a retiring City police officer their badge and allow a retiring City police officer to purchase their sidearm from the City for such consideration as the Council may deem appropriate; and

**WHEREAS**, §2.150.060(H)(3) of the Code provides that conveyances of equipment under Code §2.150.060(H) may occur without compliance with the surplus and sale procedures applicable to other types of City property; and

**WHEREAS**, City police officer Polly Harris (“Officer Harris”) is retiring from the City’s police department after 20 years of service, including 16 years with the City, and desires to obtain her City police badge (the “Badge”) and her City police department-issued Glock 19 9mm semiautomatic sidearm (serial no. BBFB872) (the “Firearm”); and

**WHEREAS**, the Chief has recommended that the Council should award Officer Harris her Badge and allow Officer Harris to purchase the Firearm from the City for \$10.00; and

**WHEREAS**, the Council met on 16 January 2024 to consider, among other things, awarding the Badge to Officer Harris and allowing Officer Harris to purchase the Firearm from the City for \$10.00; and

**WHEREAS**, the Council determined that \$10.00 is appropriate consideration for the Firearm; and

**WHEREAS**, after reviewing the Chief’s recommendation and careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the City to award Officer Harris her Badge and approve Officer Harris’s purchase of the Firearm from the City for \$10.00 in accordance with Code §2.150.060(H)(2)(a)-(b);

**NOW THEREFORE, BE IT RESOLVED** by the Cottonwood Heights city council as follows:

1. Officer Harris is hereby awarded her Badge; and
2. Officer Harris’s purchase of her Firearm from the City for \$10.00 is hereby approved.

This Resolution, assigned no. 2024-06, shall take effect immediately upon passage.
