RESOLUTION NO. 2024-31

A RESOLUTION ADOPTING A TENTATIVE BUDGET FOR THE PERIOD OF
1 JULY 2024 THROUGH 30 JUNE 2025; PROVIDING FOR PUBLIC INSPECTION
OF SUCH BUDGET; ESTABLISHING THE TIME AND PLACE OF PUBLIC HEARING
TO CONSIDER ADOPTION OF SUCH BUDGET; AND PROVIDING FOR
PUBLICATION OF NOTICE OF SUCH PUBLIC HEARING

WHEREAS, the Uniform Fiscal Procedures Act for Utah Cities (UTAH CODE ANN. §10-6-101 *et seq.*) (the “*Act*”) provides, among other things, that (a) the mayor or other budget officer shall propose a tentative budget for the upcoming fiscal year to the city’s governing body; (b) the city’s governing body shall review, consider (and amend, as advisable) and tentatively adopt such tentative budget; (c) such tentative budget shall be available for public inspection for at least ten days prior to adoption of a final budget; (d) the city’s governing body shall hold a public hearing concerning the tentative budget following at least seven days’ “Class A” public noticing as provided in UTAH CODE ANN. §63G-30-102; and (e) following such public hearing, the city’s governing body may adopt a final budget as provided in the Act; and

WHEREAS, at a meeting of the city council (the “*Council*”) of the city of Cottonwood Heights (the “*City*”) on 7 May 2024, Scott Jorges, the City’s budget officer, filed with the Council (a) a tentative budget for the City for the period of 1 July 2024 through 30 June 2025, and (b) an accompanying budget message as required by the Act; and

WHEREAS, as part of its 7 May 2024 regular meeting, the Council reviewed and considered the proposed tentative budget (the “*Tentative Budget*”) for the upcoming fiscal year; and

WHEREAS, the Council desires to fully comply with the requirements of the Act regarding adoption of a final budget for the City; and

WHEREAS, after careful consideration, the Council has determined that it is in the best interest of the health, safety and welfare of the citizens of the City to tentatively adopt the Tentative Budget as presented by the City’s budget officer;

NOW, THEREFORE, BE IT RESOLVED by the city council of the city of Cottonwood Heights that such council hereby (a) tentatively adopts the Tentative Budget; (b) orders that a public hearing (the “*Hearing*”) concerning the Tentative Budget be held on Tuesday, 4 June 2024, beginning at 7:00 p.m., or as soon thereafter as practical, at 2277 East Bengal Blvd., Cottonwood Heights, Utah, at which time all interested persons in attendance shall be given the opportunity to be heard, for or against, the Tentative Budget; (c) orders that a copy of the Tentative Budget be available for public inspection in the office of the City’s recorder (the “*Recorder*”) at 2277 East Bengal Blvd., Cottonwood Heights, Utah for at least ten days prior to the Hearing; and (d) orders the Recorder to assure that, starting at least seven days before the Hearing and continuing until the hearing occurs, notice of the Hearing is: (i) posted in at least three public locations within the City that are reasonably likely to be seen by residents of the City; (ii) published on the Utah Public

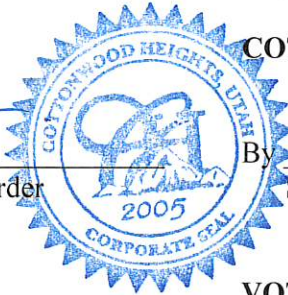
Notice Website created in UTAH CODE ANN. §63A-16-601; and (iii) published on the home page of the City's website (either in full or as a link).

This Resolution, assigned no. 2024-31, shall take effect immediately upon passage as provided herein.


